

# 國立東華大學物理學系外國學生南向獎學金施行要點

(106.4.12) 105-2-2 系務會議訂定

(106.06.15) 105 學年度第 2 學期第 5 次院行政主管會議修正通過

- 第一條 國立東華大學（本校）物理學系（本系）為配合本校南向獎學金之實行，特訂定本要點，自 106 學年度起，試行三年。
- 第二條 本獎學金申請案由本系招生委員會進行初審，並排出推薦受獎學生優先順序，本院國際事務暨獎學金委員會進行複審後送交本校外國學生申請入學暨獎學金審查小組決審。
- 第三條 本要點所稱之外國學生為符合教育部「外國學生來台就學辦法」規定之外國學生。
- 第四條 申請對象及資格概依「國立東華大學理工學院外國學生南向獎學金施行細則」（本院細則）第四條規定之，且申請人應於申請入學時繳交本系之南向獎學金申請書。
- 第五條 獎學金名額與內容依本院施行細則第五條規定，且包含獎學金內容：  
（一）生活津貼：每月新臺幣 6,000 元。（由本校提供）  
（二）研究獎勵金：每月新臺幣 8,000 元(含)以上。（由指導教授提供）  
（三）學雜費全免：不含住宿費與其他相關費用（如代辦費、保險費及網路使用費）。
- 第六條 核給期間、年限及方式  
一、 本獎學金獲獎期間由新生入學當年開始發放至多三年（六學期），第七學期起獎學金給予條件由本系另訂之。  
二、 生活津貼一年核給 12 個月，由國際事務處依審核名單於受獎期間，每月匯入獲核定受獎者在本國銀行或郵局之帳戶。  
三、 研究獎勵金一年核給 12 個月，由各指導教授於學生受獎期間配合支付，每月匯入獲核定受獎者在本國銀行或郵局之帳戶新臺幣 8,000 元(含)以上，並送國際處備查。研究獎勵金得以各指導教授或指導教授所屬學院系項下經費或計畫支應，並依相關辦法及規定辦理。  
四、 本獎學金於新生申請入學時同步審定核發人選。
- 第七條 獲核定受獎者，於受獎期間必須遵守下列規範及義務：  
一、 應於本校規定期限內完成註冊手續。  
二、 未受學校申誡處分（含）以上懲處。  
三、 應維持本校在學學生身分，因故休學或退學者，註銷受獎資格，並停止發給生活津貼及研究獎勵金。  
四、 獲獎之新生，不得申請保留入學資格。  
五、 應滿足本院細則之規定，且每學年須接受由其指導教授籌組之委員會的續獎資格審查。  
六、 未滿足上述條件者，將撤銷其獲獎資格，並於事實發生之次月起停發獎學金，惟遇特殊事故且經本系研究生委員會與系所主管，及本院國際事務暨獎學金委員會與院長，及本校外國學生申請入學暨獎學金審查小組同意者，不在此限。
- 第八條 獲核定受獎者，經查若有偽造、不實及重複領取之情事，撤銷其獲獎資格，已領取之獎學金應予繳回。
- 第九條 指導教授與本系相關規範依本院細則第九條規定，且  
（一）指導教授應於受獎者入學第一學期籌組 3 至 5 人之委員會審查其續獎資格，該委員會應訂定審查條件並明確告知受獎者，並於受獎期間將每學年之審查結果

提交本系研究生委員會及系務會議備查；

(二)若學生符合本要點獲獎與授獎資格相關規範並受獎達六學期，指導教授應提供該生後續之生活津貼每月最低 8000 元。

第十條 本要點如有未盡事宜，依本院、本校或教育部相關規定辦理。

第十一條 本要點經本系研究生委員會、系務會議及本院行政主管會議通過後實施，並送國際處備查。

# NDHU Department of Physics Southward Scholarship Regulations

- Article 1 These regulations have been formulated in line with NDHU Southward Scholarship Regulations and will be implemented on a trial basis for three years starting in the Academic Year 2017/2018 to expand the recruitment of outstanding international students.
- Article 2 A preliminary review regarding the scholarship shall be carried out by the department admission committee and recommended scholarship candidates shall be ranked in order of priority. This list shall be submitted to the International Affairs and Scholarship Committee (IASC) of the College of Science and Engineering (CSE) for a second review, and then to the International Student Admission and Scholarship Review Panel (the Review Panel) for final review.
- Article 3 The term “international student” as used in these regulations shall refer to the definitions set forth in the “Rules for International Students Undertaking Studies in Taiwan” of the Ministry of Education.
- Article 4 Application criteria and eligibility are prescribed by Article 4 of the “NDHU College of Science and Engineering Southward Scholarship Regulations” (CSESSR). Eligible applicants shall submit the “Application Form for Southward Fellowship NDHU Department of Physics”.
- Article 5 Scholarship quota and amounts are prescribed by Article 4 of the CSESSR, including the following scholarship amounts:
- (1) Stipend: NT\$6,000 per month (provided by NDHU).
  - (2) Research incentive: NT\$8,000 per month or more (provided by the supervising professor).
  - (3) Exemption from tuition and miscellaneous fees: This shall not include accommodation and other expenses (including agency, insurance, and Internet fees).
- Article 6 Scholarship award period and criteria
- (1) The scholarship shall be awarded for a maximum of three years (six semesters) starting from the year of enrolment. The recipient of further scholarship after six semesters should be referred to the regulations of the home department.
  - (2) The stipend shall be granted for twelve months per year. The monthly amount shall be deposited in a local bank or postal office account of the recipient by the Office of International Affairs (OIA) on a monthly basis in accordance with the approved list of recipients during the scholarship period.
  - (3) The research incentive shall be granted for twelve months per year. The supervising professor shall supply this incentive by depositing the annual amount into a dedicated account in the OIA for each school year during the scholarship period.

The OIA shall deposit the monthly amount into a local bank or postal office account of the recipient on a monthly basis in accordance with the approved list of recipients during the scholarship period.

- (4) Scholarship recipients shall be selected and approved during the admission application process.

Article 7 Recipients shall observe the following regulations and obligations during the scholarship period:

- (1) Completion of the registration procedures within the prescribed time limit.
- (2) No disciplinary measures at the level of reprimand or above.
- (3) Official enrolment status shall be maintained; eligibility will be revoked and payment of stipend and research incentives will be terminated upon suspension or termination of studies.
- (4) Students who have been granted this scholarship shall not apply for deferment of enrolment.
- (5) Award criteria/duties/obligations prescribed by the CSESSR must be satisfied. The student shall be reviewed every academic year through a committee organized by his/her supervising professor in view of his/her qualification for the following year's scholarship.
- (6) Failure to meet the aforementioned criteria will result in the loss of eligibility and the termination of scholarship payments starting from the month following the violation, except for emergencies or special circumstances that are subject to the approval of the related committee and the director of the department, the IASC and the Dean of the CSE, and the Review Panel of the OIA.

Article 8 If it is verified that the recipients have provided fabricated or false documents, or simultaneously received other Taiwanese government scholarships, NDHU scholarships or student-aid, the eligibility shall be revoked and the total monetary amount received from this scholarship must be repaid to the university.

Article 9 The supervising professor and the department shall follow the regulations prescribed in Article 9 of the CSESSR.

- (1) The supervising professor shall organize a committee of 3-5 persons in the first registered semester of the student who has been granted this scholarship to review his/her qualification for the following year's scholarship. The committee shall clearly inform the student with the review conditions prescribed by the committee and submit every academic year the review results to the department graduate committee as well as the Department Affairs Meeting for future reference.
- (2) If the student completes all the requirements and receive all six semesters of this scholarship, then the supervising professor shall be responsible for the student's continuing stipend which is not lower than 8,000/month.

Article 10 For matters not specifically covered in these regulations, relevant regulations of the CSE, the university or the Ministry of Education shall apply.

Article 11 These regulations have been reviewed and approved by the department graduate committee as well as the Department Affairs Meeting and the Science and Engineering Department Chairpersons' Meeting, shall be submitted to the Office of International Affairs for future reference.
