- 第一條 為配合「國立東華大學南向獎學金辦法」之實行，特訂定本要點，自 106 學年度起，試行三年。
- 第二條 本獎學金申請案由本系招生委員會及國際學生事務委員會進行初審，並排出推薦受獎學生優先順序，本院國際事務暨獎學金委員會進行複審後送交本校外國學生申請入學暨獎學金審查小組決審。
- 第三條 本要點所稱之外國學生為符合教育部「外國學生來台就學辦法」規定之外國學生。
- 第四條 申請對象及資格概依「國立東華大學理工學院外國學生南向獎學金施行辦法」(本院施行辦法)第三條之規定，且申請人應於申請入學時繳交本系之南向獎學金申請書。
- 第五條 獎學金名額與內容依本院施行辦法第四條規定，獎學金內容包含：
- (一) 生活津貼：每月新臺幣 6,000 元。(由本校提供)
 - (二) 研究獎勵金：每月新臺幣 8,000 元(含)以上。(由指導教授提供)
 - (三) 學雜費全免：不含住宿費與其他相關費用(如代辦費、保險費及網路使用費)。
- 第六條 核給期間、年限及方式
- 一、 本獎學金獲獎期間由新生入學當年開始發放至多三年(六學期)。
 - 二、 生活津貼一年核給 12 個月，由國際事務處依審核名單於受獎期間，每月匯入獲核定受獎者在本國銀行或郵局之帳戶。
 - 三、 研究獎勵金一年核給 12 個月，由各指導教授或指導教授所屬學院系，於學生受獎期間配合支付，每月匯入獲核定受獎者在本國銀行或郵局之帳戶新臺幣 8,000 元(含)以上，並送國際處備查。研究獎勵金得以各指導教授或指導教授所屬學院系項下經費或計畫支應，並依相關辦法及規定辦理。
 - 四、 本獎學金於新生申請入學時同步審定核發人選。
- 第七條 獲核定受獎者，於受獎期間必須遵守下列規範及義務：
- 一、 應於本校規定期限內完成註冊手續。
 - 二、 未受學校申誡處分(含)以上懲處。
 - 三、 應維持本校在學學生身分，因故休學或退學者，註銷受獎資格，並停止發給生活津貼及研究獎勵金。
 - 四、 獲獎之新生，不得申請保留入學資格。
 - 五、 應滿足本院外國學生南向獎學金施行辦法之規定，且每學期須接受由其指導教授籌組之續獎資格審查委員會的續獎資格審查。
 - 六、 未滿足上述條件者，將撤銷其獲獎資格，並於事實發生之次月起停發獎學金，惟遇特殊事故且經本系所務委員會與系所主管，及本院國際事務暨獎學金委員會與院長，及本校外國學生申請入學暨獎學金審查小組同意者，不在此限。
- 第八條 獲核定受獎者，經查若有偽造、不實及重複領取之情事，撤銷其獲獎資格，已領取

之獎學金應予繳回。

第九條 指導教授與本系相關規範依本院施行辦法相關規定，且

(一) 指導教授應於受獎者入學第一學期籌組由本校專任教授 3 至 5 人(含指導教授及所務委員會召集人)組成之續獎資格審查委員會審查其續獎資格。該委員會應訂定審查條件並明確告知受獎者，並於受獎期間將每學期之審查結果提交本系所務委員會及系務會議備查；

(二) 若學生符合本要點獲獎與授獎資格相關規範並受獎達六學期，未能獲得東華獎學金，指導教授應提供該生後續之生活津貼每月最低 4000 元，至多六學期。

第十條 本要點如有未盡事宜，依本院、本校或教育部相關規定辦理。

第十一條 本要點經國際學生事務委員會、系務會議及本院行政主管會議通過，並送國際處備查。

- Article 1 These regulations have been formulated in line with NDHU Southward Scholarship Regulations (NDHUSSR) and will be implemented on a trial basis for three years starting in the Academic Year 2017/2018.
- Article 2 A preliminary review regarding the scholarship shall be carried out by the Recruiting Committee and the International Students Affairs Committee to provide a recommendation of scholarship candidates with order of priority. This list shall be submitted to the International Affairs and Scholarship Committee (IASC) of the College of Science and Engineering (CSE) for a second review, and then to the International Student Admission and Scholarship Review Panel (the Review Panel) for final review.
- Article 3 The term “international student” as used in these regulations shall refer to the definitions set forth in the “Rules for International Students Undertaking Studies in Taiwan” of the Ministry of Education.
- Article 4 Application criteria and eligibility follow corresponding articles in the College of Science and Engineering Southward Scholarship Regulations (CSESSR). All applicants must submit the CSIE Southward Scholarship Application Form as part of the Admission Application.
- Article 5 Scholarship quota and amounts:
1. The total quota received from the university for CSE shall be reallocated to each of the CSE departments by the Dean of CSE and the directors of the departments.
 2. Scholarship amounts:
 - (1) Stipend: NT\$6,000 per month.
 - (2) Research incentive: NT\$8,000 per month or more.
 - (3) Exemption from tuition and miscellaneous fees: This shall not include accommodation and other expenses (including agency, insurance, and Internet fees).
- Article 6 Scholarship award period and criteria:

1. The scholarship shall be awarded for a maximum of three years (six semesters) starting from the year of enrolment.
2. The stipend shall be granted for twelve months per year. The monthly amount shall be deposited in a local bank or postal office account of the recipient by the Office of International Affairs (OIA) on a monthly basis in accordance with the approved list of recipients during the scholarship period.
3. The research incentive shall be granted for twelve months per year. This incentive shall be paid by the supervising professor or the home college/department of the supervising professor during the scholarship period, and the record should be sent to Office of International Affairs for reference. The monthly amount of NT\$ 8,000 shall be deposited in a local bank or postal account of the recipient by the supervising professor or the home college/department on a monthly basis in accordance with the approved list of recipients during the scholarship period. The funding of research incentive can come from the plans of the supervising professor or the home college/department as long as it is paid in accordance with the related regulations.
4. Scholarship recipients shall be selected and approved during the admission application process.

Article 7 Recipients shall observe the following regulations and obligations during the scholarship period:

1. Completion of the registration procedures within the prescribed time limit.
2. No disciplinary measures at the level of reprimand or above.
3. Official enrolment status shall be maintained; eligibility will be revoked and payment of stipend and research incentives will be terminated upon suspension or termination of studies.
4. Students who have been granted this scholarship shall not apply for deferment of enrolment.
5. Award criteria/duties/obligations prescribed by the home college and department must be satisfied.
6. Failure to meet the aforementioned criteria will result in the loss of eligibility and the termination of scholarship payments starting from the month following the violation, except for emergencies or special circumstances that are subject to the approval of the related committee and the director of the department, the IASC and the Dean of the CSE, and the Review Panel of the OIA.

Article 8 If it is verified that the recipients have provided fabricated or false documents, or simultaneously received other Taiwanese government scholarships, NDHU scholarships or student-aid, the eligibility shall be revoked and the total monetary amount received from this scholarship must be repaid to the university.

- Article 9 The supervising professor and the CSIE requirements:
1. Starting from the first semester of the scholarship period, the supervising professor must invite 3~5 professors of NDHU (including the supervising professor and the chair of the Graduate Program Affair Committee) to form a scholarship reviewing committee for continuous assessment of the recipient's status. The committee must determine and inform the recipient about the terms and conditions for continuous reception of the scholarship. Each semester, the committee is also responsible for submitting the recipient's assessment report to the Graduate Program Affair Committee and the Department Meeting.
 2. If the student completes all the requirements and receive all six semesters of this scholarship, and fails to receive the Dong Hwa Scholarship, then the supervising professor shall be responsible for the student's continuing stipend no lower than NT\$4,000/month for at most six semesters.
- Article 10 For matters not specifically covered in these regulations, relevant regulations of the CSESSR, NDHUSSR or the Ministry of Education shall apply.
- Article 11 These regulations, after reviewed and approved by the Graduate Program Affair Committee, the International Students Affair Committee and the Department Meeting, shall be submitted to the Office of International Affairs for future reference.
